Toelichting

- ① The number of declarations processed with this pay slip. The code number of these declarations can be found on the various parts of the payslip and on the specification on the next page.
- ② Contribution Private supplement WW and WGA. An extra gross amount is paid for this contribution and the premium is deducted net. Information about this can be found at <https://spaww.nl/english/>
- ③ Gross payments from which payroll tax must still be withheld. This is divided into a column with payments to which the normal tax rate applies and a column with payments to which the Special rate (Bijzonder tarief in Dutch) applies.
- ④ The column Cumulative shows the total amounts from the current year up to and including the week of the salary slip.
- ⑤ Total gross wage for this week. The SV wage is the amount stated under 'basis' for 'loonheffing'.
- ⑥ Summary of deductions from your salary. The specification can be found further down the pay slip. This specification shows whether we have already been able to make a deduction (in full), or whether (a part of it) still needs to be settled.
- ⑦ The Special rate percentage (Bijzonder tarief) is the tax percentage that's calculated over the payment of vacation allowance and final settlements.
